The Certificate of Agmark Grading will be issued subject to the following terms and conditions:-


- 1.The approval of the laboratory is valid on date.
- 2.The consignment has been inspected by an approved Chemist of the laboratory.
- 3.The information in the prescribed inspection report provides the complete details of the lot inspected.
- 4.All the requirements prescribed in General Grading and Marking Rules,1988 , Fruit and Vegetable Grading and Marking Rules, 2004 as amended from time to time and instructions issued from time to time are adhered to .
- 5.The authorized packers has deposited the prescribed grading charges.
- 6.The details of Certificate of Agmark Grading issued are sent to concerned office of DMI every week.

You will strictly comply with provisions of the Agricultural Produce ( Grading & Marking) Act, 1937 , General Grading & Marking Rules, 1988 (as amended) Fruit & Vegetable grading & marking rules and instructions issued by the Agricultural Marketing Adviser to the Govt. of India or an officer authorized by him from time to time. It may be ensured that grading is undertaken only by the approved chemist and certificate of Agmark grading is issued only by the following authorized designated person of the laboratory .The approval of laboratory may be withdrawn at any time by the competent authority if there are sufficient reasons to believe that grading & marking is not correctly done or that rules and instructions issued thereof are not followed and or that the laboratory has become ineligible for approval as per the guidelines issued in this regard. It is further , instructed to maintain the records related to the analysis for verification at any time .
